

Skyline at Markeaton Risk Acknowledgement and Disclaimer

MUST BE COMPLETED BY, OR ON BEHALF OF, PARTICIPANT IN ORDER TO
UNDERTAKE THE HIGH ROPES ACTIVITY

1) Skyline at Markeaton is operated by the Outdoor Education Service of Derbyshire County Council (the Council). Activities on the course can be physical, outdoor, all weather, challenging activities at height, which have inherent hazards associated with them. Whilst the Council takes all necessary precautions to try and ensure the safety of all participants, unfortunately accidents, trips, or collisions may occur as a consequence of taking part. The Council accepts no responsibility for any loss or injury resulting from any person's involvement in Skyline at Markeaton. It is understood and agreed that individuals participate at their own risk.

2) Participants should familiarise themselves with potential hazards and try and minimise these as much as possible by complying with risk management procedures, safety briefs, instructions and our guidelines. All participants must wear suitable clothing, including closed-toe footwear, and remove any loose jewellery.

3) I confirm that I am over 18 years (or giving consent for the individual named below), I am over 1.1 metres/110cm tall and weigh less than 130kg.

4) I understand that the Skyline at Markeaton activity requires a moderate level of fitness and can be physically testing and challenging.

5) I accept that there is a risk of injury when undertaking such activities. I confirm that I do not know of any existing medical or physical condition that I or any children in my care suffer from, which might have the effect of making it more likely that I may be involved in an incident, which could result in injury to myself or others. I confirm that I, nor anyone I am responsible for, is under the influence of alcohol, prescribed or non-prescribed medication prior to our participation. If unsure, please discuss this with your instructor prior to participation.

6) I will ensure my/our participation is undertaken in accordance with the specific safety instructions provided by a Skyline at Markeaton instructor before the activity commences and acknowledge that activity on Skyline at Markeaton will be undertaken without direct supervision from the course instructors following the safety briefing.

7) I acknowledge my responsibility to ensure my own safety at all times, and agree that all safety instructions given or displayed will be complied with and that all protective equipment will be worn correctly. I agree that I am responsible for any children in my care and undertake to ensure that he/she/they read, understand and will follow the instructions set out in the Safety Instructions and any oral instructions given by Skyline at Markeaton instructors.

8) I understand photographs may be taken during the session and that these may be used for marketing of the Skyline at Markeaton course.

9) In the unlikely event of an accident, or loss or damage to personal effects, to myself or the children in my care, I acknowledge that the Council will not be liable for any direct or indirect loss, damage or injury arising from or in connection with Skyline at Markeaton (except death or personal injury caused by the Council's negligence) and I waive any and all claims against the Council in this respect for both myself and/or the children in my care.

10) I accept that should a participant prove not be compliant with the height/weight restrictions or disregards safety instructions or procedures then they will be unable to participate in the activity and no refunds will be made. If I am supervising any under 18 year olds I will be required to fill in a form confirming my permission.

I acknowledge and confirm that I have read and understood the Council's Terms and Conditions, Safety Instructions and this Risk Acknowledgment and Disclaimer and I accept the terms and conditions contained therein.
